FAQs

- The Farmers Market will be held from 5–8pm
- Veteran's Park, 43 South Washington Street, North Attleborough (the park directly in front of town hall).
- Vendor Set up begins at 4pm.
- The market will be open to the community at 5pm
 - All vendors need to be set up and ready to go by 4:45pm.
 - If you are a food vendor please ensure you have everything ready for inspection.
- Upon arrival, please check in at the NAFM table and we will direct you to your spot.
 - We will be located across from the Gazebo.
- PLEASE NOTE:
 - The town is not allowing cars on the Veteran's Park lawn so please ensure you bring dollies or extra help to unload.
 - Unloading can be done at the driveway next to the town pool off of Bank Street (gate opens around 4p), from South Washington, or from the parking lot behind town hall.
 - After you unload parking is available behind town hall, on South Washington Street or Community Elementary School (next to town hall).
 - Please try to avoid parking on Bank Street to allow for residents to park for pool access.
- As a reminder, the Farmers Market is rain or shine so please be prepared to cover your products due to inclement weather. After all this is New England!
- Bathrooms are available starting at 5pm inside of Town Hall.
- Each vendor is allowed at 10x10 spot access.

- Sorry, no MLMs No Tupperware, Avon, Pampered Chef, Amway, etc, applications will be accepted. We have limited space and try to balance out the type of vendors for good customer selection and vendor sales.
- Once your application is complete, a Farmers Market team member will be in touch soon.

- ***Please note:** the Famers Market will go on rain or shine, except in the case of extreme weather. Sorry No refunds for no-shows! No Rain Checks!
- Food Vendor information:
 - If you are selling any handmade, processed foods you MUST contact the North Attleborough Department of Health.
 - A temporary food/farmers market permit is required.
 - For the 2021 season the permit fee has been waived by the town.

 - PLEASE NOTE:
 - Processed food samples should be cut, wrapped, and secured in the licensed facility in which they are manufactured and maintained at proper temperatures.

 - You will not be able to sell until all required paperwork is turned into them and you are inspected.

• Food Vendor Information:

- The following is required ONLY for vendors selling food or beverage products, except *#3, which applies to all vendors.
 - Once accepted to the market, please be sure you are able to provide the following:
- 1) Liability Insurance email to <u>farmersmarketnorthattleboro@gmail.com</u> or mail to Rachel Weiss, 77 Johnson Street, North Attleboro, MA 02760. Must list "Downtown North Attleborough Collaborative" as both additionally insured and as the certificate holder.
- 2) Board of Health application and appropriate certifications.
